Purpose

The purpose of this document is to provide the requirements and conditions for electronically filing Suspicious Activity Report by Money Services Business (SAR-MSB), FinCEN Form 109. For the purpose of these requirements, electronic filing of this report will be through the BSA E-Filing System operated by the Financial Crimes Enforcement Network (FinCEN). For more information on the BSA E-Filing System and to register, please go to <http://bsaeiling.fincen.treas.gov>. This document should be used in conjunction with the “General Specifications for Electronic Filing of Bank Secrecy Act (BSA) Reports” (General Specifications) available at http://www.fincen.gov/forms/files/e-filing_GENspecs.pdf. It is recommended that you refer to the General Specifications first, and then the specific information contained in this document.

This document should also be used in conjunction with the paper form instructions and other published FinCEN guidance. For additional guidance, refer to “FinCEN’s Preparation Guidelines for Use of Special Response “XX” in FinCEN Form 109, Suspicious Activity Report by Money Services Business (Form Date March 31, 2007” available at http://www.fincen.gov/statutes_regs/guidance/pdf/fin-2008-g006.pdf.

Electronic Filing

The BSA E-Filing System Batch File Testing Procedures are detailed in a separate document that can be accessed on the BSA E-Filing System web site at <http://bsaeiling.fincen.treas.gov> under Quick Links.

For purposes of these requirements, the filer is the organization responsible for filing the SAR-MSB and the transmitter is the organization responsible for preparing the electronic files. The filer and transmitter may be the same or different organizations.

Filers are required to retain a copy of the SAR-MSB data and all original supporting documentation or business record equivalent for five years from the date of the suspicious activity report. All supporting documentation must be made available to appropriate authorities upon request.

File Organization

The following data controls must be followed or the SAR-MSB electronic file will be rejected. The data records must be in the following sequence:

Transmitter (1A) Record - Required

There can only be one of this record type and it must be the first record on the file.

Parent Reporting Business Headquarters (2A) Record - Required

There can be more than one of this record type depending on the number of different financial institutions which are included on the file. This record type will immediately precede all records which relate to the financial institution. **Include this record with only the first two fields completed if it is the same as the Transaction Location Information (2B) Record that immediately follows this record in the file.**

Transaction Location Information (2B) Record - Required

There can be more than one of this record type depending on the number of transaction locations which are being reported. One of these records will immediately precede all SAR-MSB records for the transaction location.

Transaction Location Information (2C) Record – Multiple Selling and/or Paying Business Locations

This is for multiple locations being reported for the same SAR-MSB. There can be more than one of this record type depending on the number of transaction locations which are being reported.

Suspicious Activity Report (3A) Record - Required

There can be more than one of this record type on the file depending on the number of suspicious activities being reported by a financial institution.

Subject Information (4A) Record - Required

There can be more than one of this record type depending on the number of persons involved in this suspicious activity. There can be no more than 99 records of this type for the same Suspicious Activity Report (3A) Record.

Money Orders Information (5A) Record

Multiple 5A records are allowed.

Traveler's Checks Information (5B) Record

Multiple 5B records are allowed.

Money Transfers Information (6A) Record

Multiple 6A records are allowed.

Currency Exchange Information (6B) Record

Multiple 6B records are allowed.

Narrative (7A) Record - Required

There can be multiple occurrences of this record, depending on the length of the explanation given for the suspicious activity. There can be no more than 99 records of this type for the same Suspicious Activity Report (3A) Record.

Transaction Location Summary (9A) Record - Required

There must be one of these records for each Transaction Location Information (2B) record of a reporting business being reported. It is to be the last record associated with the 2B record.

Parent Money Services Business Summary (9B) Record - Required

There must be one of these records for each reporting business being reported. It is to be the last record associated with the reporting business and will follow the Transaction Location Summary (9A) Record for the last transaction location reported.

File Summary (9Z) Record - Required

There must be one of these records on the file and it must be the last record on the file.

Record Layouts

Transmitter (1A) Record - Required

The first record on each file is to be the transmitter record. It will contain information identifying the transmitter (person or organization handling the data accumulation and formatting). There will be only one transmitter record on each electronic file. Please note: These records are not found on the paper version of the SAR-MSB form.

Parent Reporting Business Headquarters (2A) Record - Required

This record identifies information regarding the reporting business headquarters. **If the reporting business is the same as the Transaction Location (2B) Record that immediately follows the 2A record, only the FIRST TWO (2) FIELDS of the 2A record should be completed. No other entries are required.** The number of business headquarters (parent) records will depend on the number of different reporting business headquarters which are included on the file. The 2A record item numbers refer to the SAR-MSB Form Part IV.

Transaction Location Information (2B) Record - Required

This record identifies information on the transaction location where the activity occurred. The number of transaction location records is dependent on the number of different transaction locations being reported on the electronic file. There must be at least one 2B record. **For any required item that does not apply, enter “XX”.** The 2B record item numbers refer to the SAR-MSB Form Part III.

Transaction Location Information (2C) Record - Multiple Selling and/or Paying Business Locations

This record identifies information on the transaction location where the activity occurred. The number of transaction location records is dependent on the number of different transaction locations being reported on the electronic file. If the reported activity occurred at multiple selling and/or business locations provide the information. **For any required item that does not apply, enter "XX".** The 2C record item numbers refer to the SAR-MSB Form Part III.

Attachment C – Field Editing

Instructions

These instructions apply to all SAR-MSB text fields except the Part VI Suspicious Activity Information - Narrative.

- A. Delete any name titles, prefixes, suffixes or other descriptive information such as Mr., Mrs., Dr., Reverend, Partner, Trustee, JR, or III.
- B. Delete all punctuation (e.g. “INC.” would be entered as “INC”).
- C. Do not use the following words or variations of these words in fields:
 - a. COMPUTER GENERATED
 - b. CUSTOMER
 - c. N/A
 - d. NON CUSTOMER
 - e. NONE
 - f. NOT APPLICABLE
 - g. OTHER
 - h. SAME
 - i. SAME AS ABOVE
 - j. SEE ABOVE
 - k. SEE NARRATIVE
 - l. SIGNATURE CARD
 - m. T/A
 - n. UNKNOWN
 - o. VARIOUS
- D. Multiple/compound surnames. Care must be taken in formatting foreign multiple and compound surnames that consist of multiple names. Foreign multiple surnames must be entered without punctuation in the last name field. For example, Spanish names with multiple surnames are usually written in the order of first name, father's last name, and mother's last name (e.g. Juan Vega Santiago). The father and mother last names would be entered together without punctuation in the last name field (e.g. as VEGA SANTIAGO). Compound surnames are entered with spaces and without punctuation in the last name field (e.g. VON BRAUN).
