#### **PURPOSE OF THIS GUIDE**

This guide provides instructions for formatting the RER batch XML in accordance with the published RER schema. It is intended to clarify required structure, elements, and attributes specific to the schema. This guide <u>does not</u> serve as a tutorial on XML itself. Users are expected to have a working knowledge of XML concepts, syntax, and tools in order to successfully apply the guidance provided here. To access the RER batch schema, click <u>here.</u>

#### 1. Introduction

The Real Estate Report (RER) is a form issued by FinCEN for the purpose of reporting information on transfers of certain residential real estate that are a high risk for illicit finance. FinCEN supports the following RER electronic filing methods via the BSA E-Filing System:

- <u>Single Discrete RER either via PDF form or online (web) form:</u>
   This method of filing is best suited for *lower* volume filers. Filers log in to BSA E-Filing to submit using this filing method.
- Multiple (i.e., batch) RERs in XML format:

This method of filing is best suited for *higher* volume filers who acquire (or create) software that facilitates the creation of XML files. Filers may submit a batch file manually via the BSA E-Filing website or automate the submission process via Secure File Transfer Protocol (SFTP). While FinCEN provides the ability to submit the RER data as a batch, the process of establishing a method/process to create the XML batch file is the responsibility of the filer.


#### **IMPORTANT ADVISORY**

Reporting persons are not required to report transactions that meet the definition of a "reportable transfer" and that close prior to March 1, 2026.

This user guide focuses on how to format the RER in a batch XML to submit either manually through the BSA E-Filing System website (http://bsaefiling.fincen.gov), or through <u>SFTP automation</u>. All of the above methods of RER filing are via electronic submission using FinCEN's BSA E-Filing System, which requires the submitter to obtain a <u>BSA E-Filing account</u>.

**IMPORTANT**: Prior to submitting in the production BSA E-Filing System, filers should thoroughly test their batch filing process in the BSA E-Filing \*sandbox\* environment. To access the sandbox, filers must create a separate TEST account at bsaefiling-sandbox.fincen.gov > Enroll.



#### 2. RER XML Schema Overview

Before you begin submitting RERs to FinCEN's BSA E-Filing System via XML batch, you must first review the RER batch schema to assist you with constructing and testing your XML batch file. This document helps guide the schema review process by clarifying required structure, elements, and attributes specific to the RER batch schema, such as which elements must be recorded, what the appropriate values are for each element, and what sequence the elements should be in. Please take note of the following as you review this guide:

- Simple elements have a value associated with them, while complex elements do not have a value associated with them; instead, they are containers for one or more additional elements (simple and/or complex);
- Each complex element (with the exception of the EFilingBatchXML element) must include the attribute "SeqNum" (i.e., Sequence Number) with a unique (i.e., the value cannot repeat in the batch) numeric value no greater than 19-digits;
- Element names must include the prefix "fc2" in both the opening tag and closing tag;
- Element names must match the case and spelling defined in the corresponding XML schema;
- Elements must have a matching closing tag (which includes a self-closing tag if no value is recorded for the element);
- Elements must be in the correct sequence (i.e., simple elements should be alphabetical order);
- Element names and values must NOT include leading or trailing spaces;
- Elements must be recorded once if minOccurs is not specified (or if minOccurs equals "1" in the XML schema);
- Elements may be omitted if minOccurs is equal to "0" and FinCEN guidance supports value omission (i.e., the name suffix element is minOccurs="0" and, therefore, if an individual does not have a suffix name, the element can be omitted rather than recording the element with no value);
- Elements must not be recorded in an occurrence greater than the specified maxOccurs limit (if no maxOccurs value is specific, then the maximum occurrence is "1");
- Element values must not exceed the maximum specified character limit; and
- Element values must not include non-printable characters, such as carriage returns, line feeds, and tabs.

Please also review the table below, which provides an overview of the XML Batch File Organization structure in the next section.

Column Name	Description
Element	This column corresponds with the element name in the RER XML schema. The elements must be in the order in which they are recorded in this guide.
	Elements that contain a self-closing tag (e.g., <fc2:activitypartytypecode></fc2:activitypartytypecode> ) are classified as simple elements (i.e., an element does not contain sub-elements). These elements are sometimes referred to as "child" elements.
	Elements that do not contain a self-closing tag (e.g., <fc2:activity>) are classified as complex elements (i.e., elements that contain additional subelements). These elements are sometimes referred to as "parent" elements.</fc2:activity>
	As noted previously, all complex elements (with the exception of the root element) must contain the <i>SeqNum</i> attribute.
Element restrictions	This column specifies the conditions for when and when not to record the element.
Value restrictions	This column specifies what value restrictions exist for this element, such as how many characters can be recorded, what format the value must be in, etc.
Item #	This column connects the element to the corresponding item/field in the RER form.
	<b>NOTE:</b> If you see "XML" in this column for a specific element, this means it does not correspond directly to an item/field in the RER form, but the element is needed from an XML perspective.

## 3. XML Batch File Organization


# 3.1. XML declaration (prolog)

The XML declaration (i.e., prolog) specifies the XML version and character encoding used in the file. The prolog must appear on the first line of the file.

## 3.2. EFilingBatchXML (Batch)

The EFilingBatchXML element is the root element and serves as the container for all RERs recorded in the batch XML. The EFilingBatchXML element must be the first element recorded in the batch XML.



## 3.3. Activity (RER)

#### *Hierarchy: EFilingBatchXML / Activity*

The Activity element is the container for all information regarding the RER. Each RER in the batch must begin with the Activity element.

**NOTE:** While there is no limit to the number of Activity elements (i.e., RERs) that may be recorded in a single batch XML file, the total size of the batch file should not exceed <u>60MB</u> to ensure optimal processing performance.

# 3.4. ActivityAssociation (Type of Filing)


## Hierarchy: EFilingBatchXML / Activity / ActivityAssociation

The ActivityAssociation element is the container for the type of filing (i.e., Initial report, correct/amend prior report, FinCEN directed back-filing) for the RER. This element must only be recorded once per RER.

## 3.5. Party (General)

Each RER in the batch is comprised of various Party elements with information about each person (e.g., individual, entity, trust, etc.) involved in the RER. These various Party elements are recorded at specific complex element levels within the RER depending on which person is being recorded. The image below lists all of the various simple and complex elements that may be recorded for a Party element in general; however, the elements that should be recorded will vary depending on which type of party is being recorded (see the following sections for details about each party type).



## Constraints Defined

The *constraints* referenced in the RER XML schema are intended to prevent duplicate values at the Party level for four specific elements/scenarios:

- (1) Unique-PartyNameTypeCode: Prevents duplicate name type indicators when recording multiple names for a specific Party type. For example, a Transferee Entity may have two names recorded: Legal name and Alternate name. This constraint ensures that the recording of two legal names or two alternate names for the party is flagged as invalid.
- (2) Unique-ValueTransferAddressTypeCode: Prevents duplicate address types for a single Party;
- (3) Unique-PartyldentificationTypeCode:
  Prevents duplicate forms of identification
  for a single Party;
- (4) Unique-CitizenshipCountryCodeText:
  Prevents duplicate countries of citizenship
  for a single beneficial owner Party.

# 3.5.1. Party: Reporting Person

<u>Hierarchy: EFilingBatchXML / Activity / Party</u>

This Party element is the container for information about the <u>reporting person</u> (individual or entity) recorded in Part I (Items 4-14) of the RER. The reporting person Party element is recorded under the Activity element. The reporting person Party must only be recorded <u>once</u> per RER. The reporting person Party includes the following elements:

## 3.5.2. Party: Transferee

#### Hierarchy: EFilingBatchXML / Activity / Party

This Party is the container for information about the transferee (entity or trust) recorded in Part III (Items 23-38) of the RER. The transferee Party is recorded under the Activity element. The transferee Party must be recorded at least once per RER.

## 3.5.2.1. If Transferee is an Entity

If the transferee Party is an *entity*, refer to the table below for the list of elements to include for the transferee entity. Please note the following items and corresponding elements are not included in the table below because they are not applicable to a transferee entity:

- Item 23: Transferee type Trust: TransferPartyTrustIndicator
- Item 24: Date trust instrument executed: TrustInstrumentExecutionDateText
- Item 25: If revocable trust (indicator): RevocableTrustIndicator



If your batch submission receives any of these validation errors, your <u>entire</u> batch submission will be <u>REJECTED</u> and you will need to take action to resolve the error(s) and resubmit the batch. For this reason, FinCEN strongly encourages that filers thoroughly test their XML batch filing process to ensure the RER batch files comply with:

- The published XML schema from an XML formatting perspective;
- The published Filing Instructions from an RER rule/reporting perspective; and
- The element/value restrictions described in this guide (which are consistent with the RER Filing Instructions).

#### 6. Attachment B. Server-to-Server "SDTM" Submission Automation

FinCEN provides the ability for filers to submit batch data directly to the BSA E-Filing server over a secure connection using Secure File Transfer Protocol (SFTP). This method of filing is referred to as Secure Direct Transfer Mode (SDTM). SDTM allows the batch submission process to be automated such that user intervention/involvement is minimized. To set up SDTM batch filing, please refer to the following document: BSA E-Filing SDTM Requirements

### 6.1. SDTM Batch File Naming Convention

The file naming convention is as follows: <Submission-Type>.<Date/Timestamp>.<SDTM-Username>.xml e.g., RERXST.20250525165959.sdtmtitle123.xml

- Submission-Type: This will always be RERXST
- Date/Timestamp: This will be the date/timestamp to guarantee filename uniqueness
   YYYYMMDDhhmmss
  - YYYY=Year (e.g., 2025)
  - MM=Month (e.g., 05)
  - o DD=Day (e.g., 25)
  - o hh=Hour (e.g., 16)
  - o mm=Minute (e.g., 59)
  - ss=Second (e.g., 59)
- SDTM-Username: This will be the unique username created by FinCEN for your SDTM account.

## 6.2. SDTM Submission Response Files

After successful submission of your RER batch XML, FinCEN will return two response files:

- 1. Messages file. Within a few hours of submission, FinCEN returns a "messages" file in XML format with the status of your submission (e.g., accepted or rejected) and any errors associated with the submission. The name of this file will match your batch file name but with \*.MESSAGES.XML appended to the end of the name. The schema associated with this XML is located here: <a href="https://www.bsaefiling.fincen.gov/resources/MESSAGES.xsd">www.bsaefiling.fincen.gov/resources/MESSAGES.xsd</a>
- 2. Acknowledgement file. Within 1-2 business days after an *accepted* submission, FinCEN returns an "acknowledgement" file in XML format with the BSA Identifier assigned to each RER in your batch. The name of this file will match your batch file name but with \*.ACKED appended to the end of the name. See Section 4 RER XML Batch Acknowledgement for details about this file.

#### 6.3. SDTM Account Creation
